 - 5. Total annual fuel cost for your company for 2009.
 - 6. Total annual franchise fees paid by your company for 2009.
 - 7. Total annual labor costs incurred by your company for 2009.

- 8. Total Depreciation Expense for your company for 2009.
- 9. Total Income Taxes paid by your company for 2009.
- 10. Total other Taxes (excluding franchise fees) paid by your company for 2009.
- 11. Total amount of other Operation and Maintenance Expenses incurred by your company for 2009.
 - 12. Total amount of interest on long-term debt for your company for 2009.
 - 13. Total amount of interest for other debt for your company for 2009.
 - 14. Total amount of common stock dividends paid by your company for 2009.
 - 15. Total amount of preferred stock dividends paid by your company for 2009.
- 16. Total annual revenue from passenger ticket sales for your company for 2007-2009.
- 17. Total annual revenue from sources other than passenger ticket sales for your company for 2009.
- 18. Total number of passengers in each revenue class (i.e., adult roundtrip, adult one-way, child roundtrip, commuter, non-commuter, etc.) carried by your company for 2007-2009.
- 19. Number of trips by month for each month in 2009 where each trip consists of one way travel between any two points.
